MUTTZ GYM, LLC RELEASE AND WAIVER OF LIABILITY

I (We), the undersigned hereby consent and agree in all respects to the following:

- RISK OF INJURY AND PROPERTY DAMAGE.** I understand that my participation in a Muttz Gym, LLC class/session necessarily involves the risk of injury to me, my dog, my family/guests and others due to the unpredictable nature of dogs and the surrounding environment. I understand that there is risk of damage to my property, injury or even death to myself, members of my family or guests who may attend, my dog or third parties and other dogs. I elect to participate regardless of this known risk.
- PHYSICAL CONDITION OF MY PET.** I represent and warrant that my dog is physically fit and has no medical or other condition which would prevent his full participation in any Muttz Gym, LLC class. I agree to bring my dog clean and free of fleas and parasites before any class along with proof that my dog has received required vaccinations associated with the dog's age. These vaccinations are to remain current throughout the duration of classes.
- ASSUMPTION OF RESPONSIBILITY FOR PET.** In consideration for mine and my pet's participation in the Muttz Gym, LLC classes, I agree to assume full responsibility for any risks, injuries or damages, known or unknown, which may occur to anyone as a result of my dog participating in Muttz Gym, LLC classes.
- WAIVER OF LIABILITY.** In further consideration of my dog being permitted to participate in Muttz Gym, LLC classes, I knowingly, voluntarily and expressly waive any claim I may have against Muttz Gym, LLC (including its employees, owners and agents) for injury or damages which I, my family or guests or my dog may sustain as a result of participating in these dog training classes. I hereby waive any and all claims and release Muttz Gym, LLC (including its employees, owners and agents) from any and all liability of any kind or nature or from any damage, which I or my dog may suffer, whether known or unknown, during any training class (including coming and going from all training classes). I further assume all risk of any such damage or injury while attending any training session held by Muttz Gym, LLC. I, on behalf of myself and my heirs or legal representatives, forever release, waive, discharge and covenant not to sue (or otherwise take legal action against) Muttz Gym, LLC (or its employees, owners and agents) for any damage, injury or death caused by their actions or inactions (other than intentional acts or gross negligence) during the training of my dog or while on the training premises or the surrounding area.
- CONSENT TO USE OF PHOTOS OR IMAGES.** I understand and agree that during any class Muttz Gym, LLC reserves the right to take photographic, video or other images of the classes and the participants and their pets. I hereby consent and permit Muttz Gym, LLC to use any and all images of myself, family or my pet(s) for use on their website, advertising or for any other purpose without compensation or any further consideration.

In the event any amount is due to Muttz Gym, LLC and remains unpaid after written notice by Muttz Gym, LLC, or any other dispute arises related to this Agreement or the related services, I hereby agree to pay for any and all collection costs (including attorneys' fees and court costs if necessary) incurred by Muttz Gym, LLC to collect payment or enforce the terms of this Agreement.
